3. HIGHLIGHTS OF ACTIVITIES IN 2024

3.1 Surveillance Audit on Accreditation to MS ISO/IEC 17024

The Secretariat received Certification of Accreditation to ISO/IEC 17024 with the accreditation number ACB PS 0006 on 29th March 2021 from Standards Malaysia. The covered schemes are the Mechanical Joint Integrity (MJI) and Coating Inspector (CI) certification schemes.

An annual Internal Audit for compliance with MS ISO/IEC 17024 was conducted at the IMM office from 15th to 19th July 2024. During the audit, five (5) minor NCRs were identified. The Secretariat submitted the evidence and corrective plans, which were verified and closed by the Lead Auditor on 6th September 2024.

3.2 Training, Examination and Certification

A total of one hundred and twenty-six (126) IMM certification examinations were conducted in 2024. Most of these examinations were held in conjunction with the corresponding training programs conducted by the Associate Training Partner (ATP) and Authorized Training Bodies (ATBs). 3.3 IMM Membership

A total of one thousand two hundred and seven (1,207) new admissions were recorded as IMM Membership in 2024. These applications were primarily obtained through various channels, including the IMM examination, conference activities, social media platforms, the IMM website, and webinars/seminars organized by IMM committee members. Regular meetings were held to discuss the plans for the committee.


3.9 Insulation Committee [Chair: Mr. Danny Tan Kim Chew]


A presentation on the Thermal Insulation Standard was delivered at the AMVIP Coatings and Insulation Conference in October 2024.
